

Newport Partners Income Fund Acquires Bear Rock LP's Minority Interest in NPC Integrity Energy Services

Toronto – December 20, 2010 – Newport Partners Income Fund (the "**Fund**") (TSX:NPF.UN, NPF.DB and NPF.DB.A) announced today that its indirect wholly-owned subsidiary, Newport Partners Holdings LP, has acquired all of the Class A Units of NPC Integrity Energy Services Limited Partnership ("**NPC**") held by Bear Rock LP for approximately \$15.3 million in cash. As a result of the acquisition, the Fund indirectly owns 100% of the outstanding securities of NPC.

NPC is an established oilfield services company serving traditional oil & gas and oil sands-related production companies. NPC provides a wide range of services required by today's major energy producers in Western Canada including maintenance, turnaround and construction services, field maintenance, pipe fabrication and assembly, highly-skilled welding, wear technology, machining, repair and transportation supply services.
